Thursday, April 21, 2022

#### **MEETING SUMMARY - FINAL**

#### Welcome - Katie Malinowski

Katie Malinowski called the meeting to order at 6 p.m. EST and welcomed everyone to meeting #15. Bill Crist was unable to make the meeting.

#### Old Business - Katie Malinowski

A motion was put forward to approve the January 2022 advisory council meeting minutes. Motion to approve by Bob Morgan and seconded by Gail Smith.

#### New York State Presentation Introduction - Katie Malinowski

Katie introduced Nancy Herter, Director, Technical Preservation Services at the Division of Historic Preservation at OPRHD (by phone), Christina Reith, New York State Museum, state archaeologist and co-director of the cultural resources survey program, and Michael Lucas, curator of historical archaeology. Great to have NY state presenting tonight information and really important for the SAC to understand the underwater archaeology programs in NY state and the authorities these branches bring to the table to consider how NOAA and the state in a co-management partnership can provide additional protection and more interpretation on maritime historical resources. This will help the SAC think about and articulate a national marine sanctuary in Lake Ontario.

# Office of Parks, Recreation and Historic Preservation

# Nancy Herter: Director, Technical Preservation Services Bureau, Division for Historic Preservation

- Nancy Herter provided a presentation on the Compliance Review Program. Nancy's staff
  primarily focuses on compliance review programs that will intersect with the proposed
  LONMS. Important functions include providing recommendations to federal, state and
  local agencies with recommendations on how projects might affect cultural resources
  under Section 106. Under NY state law the State Historic Preservation Act mirrors
  Section 106.
- Reviews projects for a number of different agencies including federal, state and agencies (example: review of wind farms or fiber optic cables -- fiber optic cables from US to Canada that would potentially go across Lake Ontario).

- Reviews and places cultural resources on the National Register of Historic Places. Five property types are buildings, structures (can be a floating object), objects, sites such as archaeological
- Will work alongside NOAA in the future on national register nominations.
- SHPO has a large inventory of archaeological sites, buildings and structures (some are eligible and some are not) recorded in GIS system

# Christina Rieth: State Archaeologist and Co-Director of the Cultural Resources Survey

Christina thanked the council for the opportunity to provide a presentation on cultural resources and Section 233.

- Section 233 protects publicly owned cultural resources for scientific, educational and historic purposes.
- Section 233 has three components (1) protecting archaeological sites and objects of historic interest preventing artifact removal from state lands; (2) provides archaeological study permits (through Office of General Services) for individuals to do legitimate research on state lands, and (3) requires individuals who find archaeological artifacts to report to the proper agencies in New York.
- Applications are sent to the State Museum for interagency approval. Approved permits are sent to the state agency who administers the land.
- Curation of artifacts are housed under the NY State Museum
- Submerged heritage preserves include historical shipwrecks and other submerged archaeological resources are marked by a round mooring buoy that allows access to the site. DEC oversees the submerged heritage preserves along with the Office of General Services

# Michael Lucas: Curator of Historical Archaeology

- Resources that have been curated in New York are kept in a database. Also want to
  dovetail where historical archaeological ducts into this. Artifacts are curated for
  perpetuity in NY. Anytime something is removed from state waterways it's a law that it
  belongs to the State of NY which means it belongs to the state museum.
- Office jumps in for long term curation. Very important when projects come along in the section 233 process or survey to be included in the discussion making process to ensure funding is there for long term conservation.
- Underwater projects under Section 233 were consulted before curation. Resources need
  to be preserved in stable and anaerobic environments (costing more money). The office
  comes in at the end of the projects and determines how resources will be preserved for
  the residents in the State of NY.

# Q&A:

Ellen: What does the collection look like?

**Michael**: The State of NY owns a World Trade Center ship falling under historical archaeology. Usually the collection will include portions of ships or ship-related things like anchors. There are a number of different projects that have shipwreck components. Some of these are on long term loans. There is a loan program in Long Island which started in the 1970s or early 1980s. When something comes into the office's collection it can be loaned out to institutions for public outreach or display. If NOAA wanted to partner with museums, New York has a loan process which is a straightforward guideline on a yearly basis. Items belong to the New York State Museum who oversees the long term for oversight on long term loans for resources.

**Ellen:** In the Great Lakes they are all in state waters and bottomlands, so NOAA doesn't take over any of the state resources or management. Ellen introduced William Hoffman who will be helping with Section 106 and helping us to understand the procedures.

# **NOAA Updates – Ellen Brody**

• Designation process: reminder/refresher last summer published draft management plan but did not publish the draft rule. Currently in NOAA for review and targeting summer for release. The proposed rule will include the proposed boundary (decision will have been made by NOAA) and building on the draft EIS where we had the regulatory concepts, had taken the comments and made them into language. When these are published we will have another public comment period, both in-person and virtual. As we get closer to knowing when the document will be published, we may organize our next SAC meeting

- with the release of the document. Hoping there aren't many changes and move forward with publishing the final impact statement, final rule, final management plan. Timeframe for designation is about one year away.
- 50<sup>th</sup> anniversary. Our artist/graphic designer has been creating posters for each sanctuary (one a month) and will be completed by the 50<sup>th</sup> anniversary. On our website for download.
- Capitol Hill Ocean Week (CHOW). Annual event in June and it will be hybrid this year. Interesting agenda. CHOW is hosted by the National Marine Sanctuary Foundation and is an annual celebratory event. Visionary for our program, oceans and Great Lakes.
- Expedition ship Viking. In three weeks, the ship will be in Thunder Bay on May 3<sup>rd</sup>. NOAA has a formal relationship with Viking. The goal for Viking and their passengers is to provide opportunities to perform science on the Great Lakes, collect data and experience it. This year there are three cruises. We will have some staff on board between Milwaukee and Alpena. Next year, they will start in Ft. Lauderdale and come up the coast to Toronto. This is an incredible opportunity for the sanctuary program. Some disappointment that Viking wasn't going to come through Eastern Lake Ontario, however Viking will be coming through the St. Lawrence next year. Stay tuned. - · The Joint Sterling/Fair Haven Local Waterfront Revitalization Plan is moving forward and now includes over 60 capital and planning projects ranging from lakeshore and resource protection to education, recreation and capital project developments. The planning process will wrap up in Q2 2023.
